## **HFS Adds Prior Authorization Review Requirement**

As a provision of Public Act 097-0689 Save Medicaid and Resources Together (SMART) Act, Healthcare and Family Services (HFS) recently announced prior authorization review for *elective*, coronary artery bypass grafts and back surgery procedures. All ICD-9 procedures identified in HFS' new Attachment F will be subject to prior authorization review, effective with planned general *inpatient* admissions starting April 1, 2014. **eQHealth will begin accepting your requests for prior authorization on March 1<sup>st</sup> for scheduled procedures with admissions starting April 1, 2014.** Here is an overview of the prior authorization review requirements:

Description	Request Method	Requirements/Timeframe	Determination
Regardless of hospital payment type:  <i><u>Prior authorization is required for elective procedures subject to review on HFS Attachment F scheduled on and after April 1, 2014.</u></i>	A member of the hospital staff must request prior authorization online via eQHealth's Web system, eQSuite™.	Requests must be submitted to eQHealth via the Web: <ul style="list-style-type: none"> <li>• <u>Up to 30 calendar days prior to procedure date.</u></li> <li>• <u>No later than 3 business days prior to procedure date (more if requested before a holiday).</u></li> </ul> <p><i>The authorization number (TAN) will be valid for 60 calendar days.</i></p>	A medical necessity determination will be rendered within 2 business days from receipt of all necessary information.  <i>If denied, an expedited reconsideration may be requested.</i>

- 1) Download the Prior Authorization Provider Manual** from our Web site at <http://il.eqhs.org> under the 'PriorAuthResources' tab. The surgeon/office must provide the hospital with specific medical information needed for review. A prior authorization *template* for hospital/surgeon communications is offered in this manual.
- 2) Contact your Case Management Department** to find out who the eQHealth Medicaid Liaison is for your hospital. All review notifications will be faxed to this contact.
- 3) Hospital Admissions/Intake/Case Management eQSuite™ Access**  
*Already Use eQSuite™?* Starting March 1, 2014, you may log on with your existing user name and password. Click "Create a New Review" just as you do for inpatient admission. On the *Start* tab, there will be a new "HFS Admission Type" drop down. You will choose Prior Authorization HFS Attachment F - CABG or Prior Authorization HFS Attachment F – Back.  
*Need Access to eQSuite™?* Your hospital-assigned eQHealth Web Administrator can create a secure user name and password for you. If your hospital does not have a Web Administrator, please fill out an eQHealth *Hospital Contact Form* and assign this role to get access to eQSuite™.
